# 2023 ANNUAL DIRECTORS' REPORT – POLOCROSSE AUSTRALIA

#### Introduction

This Directors' Report for Polocrosse Australia Limited (Polocrosse Australia), a company limited by guarantee, has been prepared for the financial year ending on 31 December 2023 in accordance with section 300B of the Corporations Act 2001 (Cth).

#### This Directors' Report:

- 1. contains a report on the short-term and long-term objectives of the company;
- 2. sets out the entity's strategy for achieving those objectives;
- 3. states the entity's principal activities during the year;
- 4. states how those activities assisted in achieving the entity's objectives;
- 5. states how the entity measures its performance, including any key performance indicators used by the entity;
- 6. includes details of the name of each person who has been a director of the company at any time during or since the end of the year and the period for which the person was a director;
- 7. provides each director's qualifications, experience and special responsibilities;
- 8. outlines the number of meetings of the board of directors held during the year and each director's attendance at those meetings;
- 9. includes for each class of membership in the company the amount which a member of that class is liable to contribute if the company is wound up; and the total amount that members of the company are liable to contribute if the company is wound up.

#### **Objectives of the Company**

The vision of Polocrosse Australia is to successfully lead the sustainable growth of polocrosse in Australia through strong leadership, governance, financial management and a commitment to our members and the wellbeing of all players and horses.

This vision and the strategies to achieve this vision are outlined in the Polocrosse Australia 2023-2026 Strategic Plan, developed by the Polocrosse Australia Board. The Strategic Plan identifies three specific areas of priority on which to focus during the next three years:

- governance,
- participation and growth, and
- business development.

#### **Strategies for Achieving Objectives**

These strategic priorities have been driven by member feedback and have shaped the focus for this strategic planning period.

During the period 2023 –2026 Polocrosse Australia will:

- develop and deliver effective governance, management and leadership strategies to create and maintain an inclusive, vibrant and sustainable national sporting organisation
- support the growth and development of all categories of membership to promote participation from social involvement through to the elite levels of polocrosse; and
- strive to create a strong financial base to ensure the ongoing financial viability of the organisation and to support participation and growth of the sport at a national level.

During 2023 the Board developed a comprehensive Operational plan that outlines how Polocrosse Australia will achieve these strategic priorities.

## Principal Activities, Achievement of Objectives and Performance Management

During 2023 Polocrosse Australia has focused on and will continue to focus on:

- reviewing and updating governance structures, policies and procedures, and the code of conduct, to ensure they meet Australian Sports Commission Standards, the ever-changing environment in which we operate and the safety and wellbeing of our members and their horses;
- adhere to best-practice business management principles to ensure the financial viability of the organisation and to meet the auditing requirements under which the organisation operates;
- implementing pathways and strategies to ensure all stakeholders are aware of and have input to key decisions and activities carried out at a national level;
- invest in annual professional development programs to ensure all Board members have the skills required to meet their obligations as Polocrosse Australia directors;
- working closely with state and territory polocrosse associations to grow participation in
  polocrosse and develop the skills of players at all levels in each state and territory, through
  the development of resources, promotion of state, territory, national and international
  initiatives, revitalization of the Polocrosse Australia website;
- actively supporting the skills development of all players (from social to elite level), umpires, coaches and state, territory and club executives through a range of pathways and development programs;
- supporting opportunities for players to participate in national and international competition;
- actively seeking commercial partnerships and sponsorship opportunities to ensure the financial viability and growth of the business; and
- actively seeking government funding opportunities to ensure the financial viability and growth of the business.

Examples of specific activities carried out during 2023 that assist Polocrosse Australia to achieve its objectives include:

#### Governance

- finalise the 2023–2026 Strategic plan;
- developed, finalised and implementing the 2023–24 Operational plan;
- established a list of NSWO compliance requirements;
- reviewed and adopted Sports Integrity Australia (SIA) policies;
- reviewing and updating Polocrosse Australia policies as required (in progress);
- reviewing and update the Polocrosse Australia Rule book (in progress);
- monitoring the implementation of Polocrosse Australia policies, procedures and rules and carry out disciplinary actions as required (ongoing);
- set annual operating budget, review and managing finances in conjunction with the Polocrosse Australia Treasurer;
- committed the support of one Board member to each state and territory polocrosse association to support the flow of communication at all times between grassroots polocrosse and representation at the national level;
- identified additional opportunities to build stronger two-way communication between States and Territories and PA Board (e.g. President's Get Together, All States forum)
- developed a communications plan to guide engagement across the breadth of internal and external target stakeholders;
- refreshed the Polocrosse Australia website to ensure current information is available across the breadth of internal and external target stakeholders;
- ensured all new Board members complete the SportAUS Director Education Course –
   The Starting Line within three months of their appointment;

#### Participation and growth

- supported and promoted state and territory, national and initiatives through Polocrosse Australia communication channels, such as facebook, instagram and direct emails;
- actively monitored player numbers on a monthly basis to better understand membership changes;
- created initiatives to celebrate and encourage member participation, such as the World Cup communications campaign;
- established a Board liaison officer to support the National Umpiring Committee;
- established a Board liaison to support the National Coaching Coordinator;
- initiated the Educate, promote and grow project to promote and support opportunities for players, coaches and umpires across all levels to develop skills and support horse welfare leading up to and during the polocrosse season;

#### • Business development

- Developed a sponsorship prospectus to support approaches to potential partners and sponsors for the World Cup
- kept track of government funding opportunities applicable to Polocrosse Australia and applied for relevant funding, such as the Play Well grant.

Polocrosse Australia's Operational plan 2023–2024 clearly outlines the activities the entity will undertake in order to achieve the objectives outlined in the Strategic plan and includes key performance indicators for each activity in order to measure performance.
