POLOCROSSE AUSTRALIA 2024 ANNUAL DIRECTORS' REPORT

The Directors present their report together with the financial report of Polocrosse Australia Limited for period from 1 January 2024 to 31 December 2024 and the auditor's report thereon.

Principal activities

Polocrosse Australia is recognised by the sport's international body, International Polocrosse Council (IPC), and is delegated to govern the sport of Polocrosse in Australia. To carry out the company's strategies and to achieve its short-term and long-term objectives, the company's principal activities during the year were the promotion and administration of polocrosse in Australia across all disciplines from grassroots through to the operation of the Australian Polocrosse team.

Short term objectives and strategies

The growth of polocrosse is a shared responsibility of many stakeholders. 2024 marked the second year of Polocrosse Australia's strategy and our short-term priority was to continue to strengthen our foundation and highlighting our sport by:

- Unifying the sport and strengthening our relationship with states and territories;
- Achieving re-recognition and funding support with Australian Sport Commission;
- Diversifying revenue streams to create a more sustainable financial position;
- Refreshing organisational governance practices to optimise capabilities;
- Showcasing elite pathways with successful Nationals Championships and World Cup campaigns

Long term objectives and strategies

Polocrosse Australia's aspiration is to be the global leader in polocrosse – respected for our positive impact on and off the polocrosse field. To achieve this our strategy focuses on three key pillars:

Governance: develop and deliver effective governance, management and leadership strategies to create and maintain an inclusive, vibrant and sustainable national sporting organisation.

Participation and growth: actively support the growth and development of all categories of membership to promote participation from social involvement through to the elite levels of polocrosse.

Business development: create a strong financial base to ensure the ongoing financial viability of the organisation and to support participation and growth of the sport at a national level.
